



## Ovulation Induction/IUI Treatment costs

At Coastal IVF all cycles are provided at a standard cycle fee without add-on costs.

When a cycle is planned, you will receive a written quote specific for your care- this lists all costs in advance and the quotation outlines the payment schedule before you commit to treatment.

Attached is the payment schedule and fees representative for a typical Ovulation Induction/Intrauterine insemination cycle.

The table below provides you with a summary of the expected Medicare and Safety Net rebates plus the calculated final out-of-pocket costs associated with an IVF treatment cycle at CIVF.

Ovulation Induction/IUI Treatment cycle	Expected Rebates	Expected final out of pocket costs
1st Cycle - \$1400.00	\$602.50	\$797.50
2nd Cycle - \$1300.00	\$602.50	\$697.50
3rd Cycle - \$1100.00	\$602.50	\$497.50

### Non-standard Procedure costs- required in certain circumstances only

- Sperm Analysis + HBA Testing: (outside of an ART cycle) - \$150.00
- Sperm Cryopreservation (Includes storage for short term) \$250.00 – Subsequent samples \$100.00.
- Donor Sperm \$800 (Coastal IVF) \$1650 (Central IVF) \$2500.00 (Seattle)
- Annual storage fee (semen) \$450.00 per annum. The storage program and payments are managed by Embryo Options on behalf of Coastal IVF. You will receive an email invitation from Embryo Options approximately 2 months after the initial freeze date regarding your long term storage options and associated costs.



## Informed financial consent

At Coastal IVF/O&G we believe all patients should be fully informed of the costs they may incur for the service or treatment provided. Please read and acknowledge the following information:

- You will always be provided an estimate of costs for your appointment, treatment or procedure and your expected out-of-pocket costs, prior to commencing any treatment. We try to ensure this is as comprehensive as possible, but Coastal IVF relies upon the information provided by yourself, Medicare and your Health fund when providing an estimate.
- A valid G.P or specialist referral is required throughout the course of your treatment to be eligible for Medicare rebates.
- Please be aware as with any medical procedure, whilst every effort is made to provide an accurate estimate of the costs you may incur; the out-of-pocket costs may vary. This may be due to specific terms of your Medicare status, health fund status and your policy exclusions.
- If clinically indicated, some procedures may need to be sent to a pathology laboratory for testing. You may have an out-of-pocket cost on these tests, depending on your health fund policy or if you are uninsured. This cost can be up to as much as \$1000.00 in certain circumstances. This fee is payable directly to the 3rd party laboratory provider. Coastal IVF are not responsible for this fee. Please speak to your specialist regarding pathology testing requirements if you have any concerns, prior to your procedure.
- You or your nominee agree to pay any outstanding balance if Medicare or your health fund do not cover the costs of your treatment.
- If unforeseen circumstances arise during your procedure or individualised treatment, it may be necessary to arrange additional medical services or use a different or more costly method of treatment. If this happens you will be informed and there may be additional costs to you that are not covered by the initial estimate.
- Surgical procedures in hospital may occasionally attract a 'Surgical assistant' GAP fee. Usually up to a maximum of \$200.00. The assistant will invoice you directly for payment following your procedure.
- You agree to pay any balance of costs incurred, as a condition of commencement of treatment once you have indicated your acceptance of these terms.
